Any person present who wishes to vote is treated as having applied for and been admitted to membership for the purposes of this meeting.

Important Information for Members

The trustees wish to reassure members that Blunham Village Hall is currently operating as normal, and there is no intention to close the Hall at this time.

The inclusion of a resolution relating to the potential future winding up of the charity reflects the trustees' responsibility to plan prudently in light of ongoing difficulties in recruiting volunteers and trustees to fill essential governance and operational roles.

The proposed resolution does not authorise the immediate closure of the charity, nor does it remove the requirement for a formal members' decision in accordance with the constitution should winding up ever be proposed. It is intended to record members' awareness of the issue and their support for the trustees considering appropriate next steps only if a final recruitment campaign, running until 31 March 2026, is unsuccessful.

The trustees remain fully committed to the continuation of the Village Hall and are actively seeking new volunteers and trustees to secure its long-term future. Members' support and involvement are strongly encouraged.

Special Business

Resolution 1 – Sustainability and Future Viability of the CIO

(Proposed as a resolution requiring a 75% majority)

“That the members recognise that the continued operation of the CIO depends upon the successful recruitment of individuals to the essential voluntary roles of Chair, Booking Clerk, Secretary and Event Co-ordinator, and agree that if those roles have not been successfully filled by 31 March 2026, the trustees should consider whether it is in the best interests of the CIO to propose that the CIO be wound up in accordance with clause 29 of the constitution, including by convening a general meeting of the members for that purpose without undue delay.”

Special Resolution 2 – Amendment to Clause 16 (Trustee Terms of Office)

(Proposed as a special resolution)

“That clause 16 of the constitution, which limits the number of consecutive terms a charity trustee may serve, be deleted and replaced with the following wording:

‘A charity trustee who retires by rotation or otherwise ceases to hold office is eligible for reappointment, provided they remain eligible to serve, and there shall be no limit on the number of consecutive terms a charity trustee may serve.’”

Any Other Business

Voting and Attendance

Each member present has one vote.

Special resolutions require a 75% majority of votes cast in order to be passed, in accordance with the CIO constitution.
